Excellency,

I have the honour to write to you with regard to ongoing efforts of the Panel of Experts established pursuant to United Nations Security Council resolution 1874 (2009) to gather, examine and analyse information regarding the implementation of the measures imposed on the Democratic People's Republic of Korea (DPRK) by Security Council resolutions 1718 (2006), 1874 (2009), 2087 (2013), 2094 (2013), 2270 (2016), 2321 (2016), 2356 (2017), 2371 (2017) and 2375 (2017).

The Security Council and its Committee established pursuant to resolution 1718 (2006) (1718 Committee) have designated certain individuals and entities for targeted sanctions! (i.e. travel ban and/or assets freeze). With regard to the travel ban measure, Member States are obliged to prevent the entry into or transit through their territories of designated individuals and any other individuals whom a State determines is working on behalf or at the direction of a designated individual or entity, assisting in the evasion of sanctions, or violating the provisions of relevant Security Council resolutions².

As part of its mandate, the Panel conducts an annual investigation into the travel movements and activities of certain individuals in connection with the evasion of United Nations sanctions and/or the violation of the Security Council resolutions regarding the DPRK for possible reporting and recommendations to the Security Council. In its efforts to gather reliable and verifiable information, the Panel would therefore be grateful for the assistance of Botswana's competent authorities in supplying the following information:

- Immigration, entry/exit and transit records for your <u>land</u>, <u>air and any sea</u>
 <u>borders</u>, including dates of arrival, transit or departure, related to the
 individuals listed in Annex 1 for the period between 1 January 2012 and the
 date of this letter (including any records that may have been maintained or
 stored by third parties).
- Visa and/or diplomatic accreditation records (including where possible passport copies) relating to those individuals listed in Annex 1 for which your records show were granted visas or diplomatic or other forms of accreditation in your territories for the period 1 January 2012 and the date of this letter (including any records that may have been maintained or stored by third parties).

Paragraph 5 of the Security Council resolution <u>2345 (2017)</u> urges all Member States and other interested parties to cooperate fully with the Panel of Experts, in particular by supplying any information at their disposal.

The Panel would welcome any other information that you might consider relevant to its work as mandated by the Security Council in this regard. In addition, the Panel would like to assure you that any information you may consider confidential can be handled accordingly and used solely for the information of the Security Council and the 1718 Committee.

Given the importance the Panel attaches to this investigation, we would be most grateful for any information to be supplied within two months of the date of this letter.

Annex 2: Explanatory note on individuals who have acted on behalf or at the direction of designated entities; those who have been involved in the violations of the UN Security Council resolutions or those being investigated by the Panel for their possible role in assisting in the evasion of sanctions.

According to information obtained by the Panel, individuals listed below have acted on behalf of or at the direction of the entities that were designated by the Security Council or the 1718 Committee for targeted sanctions; or have been involved in the violations of the UN Security Council resolutions; or are being investigated by the Panel for their possible role in assisting in the evasion of sanctions or violations of the resolutions. The Panel wishes to obtain records of their movements in order to investigate any activities conducted by them in violation of the resolutions or their possible involvement in incidents of noncompliance.

1. <u>Individuals connected to Green Pine Associated Corporation (aka Saeng P'il) or the Reconnaissance General Bureau (RGB)</u>

On 2 May 2012, the Security Council 1718 Committee designated Green Pine Associated Corporation for targeted sanctions (S/2012/287) (as KPe.010 in the List of individuals and entities subject to the measures imposed by paragraphs 8(d) and 8 (e) of Security Council resolution 1718 (2006)³). The 1718 Sanctions List notes that the entity had taken over many of the activities of KOMID which was designated by the Committee in April 2009. On the 2 March 2016, the United Nations Security Council designated the DPRK's Reconnaissance General Bureau (RGB) for assets freeze (as KPe.031) under Security Council resolution 2270 (2016). The Security Council noted that the RGB "is the DPRK's premier intelligence organization, created in early 2009 by the merger of existing intelligence organizations from the Korean Workers' Party, the Operations Department and Office 35, and the Reconnaissance Bureau of the Korean People's Army. The Reconnaissance General Bureau trades in conventional arms and controls the DPRK conventional arms firm Green Pine Associated Corporation."

Other information: Mr. An has been identified as Green Pine Associated Corporation representative in Egypt and suspected to be an agent of the Reconnaissance General Bureau (RGB). He is named as the DPRK's Ministry of Military Equipment representative for the Middle East and Africa and is authorized to enter into contracts, fulfilment and banking activities. Mr. An was serving as a diplomat at the DPRK embassy in Cairo, Egypt. (See Panel 2017 Final Report, S/2017/150, para. 182 and annexes 14-25).

1976, Passport no.: 563320095), the deputy representative of DPRK shipping office in Vladivostok.

For the sale of Li-6, Mr. YUN and GPM used an address and phone number in Beijing, China. A Mr. YUN Chol appears in the official diplomatic list as Third Secretary at the DPRK embassy in Beijing and the Panel continues to investigate this diplomat's involvement in prohibited activities (see Panel 2017 Final Report S/2017/150, para 24 -25 and annexes 4-4 to 4-6).

2. <u>Individuals reportedly acting on behalf of KOMID and Korea Tangun Trading</u> Corporation

According to the information published by the Department of the Treasury of the United States of America, individuals listed below have worked for KOMID, Tanchon Commercial Bank or Korea Tangun Trading Corporation. KOMID was designated for assets freeze by the Security Council 1718 Committee in April 2009 (as KPe.001) and is the DPRK's primary arms dealer and main exporter of goods and equipment related to ballistic missiles and conventional weapons. Korea Tangun Trading Corporation was designated for assets freeze by the Security Council 1718 Committee in July 2009 (as KPe.008) as a DPRK entity responsible for the procurement of commodities and technologies to support DPRK's defense research and development.

Additional information provided by the United States Treasury states that Hwang Su Man directly coordinated with KOMID headquarters officials and worked in Africa to develop a new market for the sale of KOMID products.
